


- Farrukh Sabzwari was unable to attend due to an important meeting in the capital, but his contribution to strengthening professional institutions in Pakistan was acknowledged.

of Income Tax Return and Wealth Statement Tax Year: 2025 Period: Ist July 2024 till 30 June 2025

- · Copy of CNIC, registered cell number and email ID-in case of non-registered person, OR
- In case of Registered Person:
- · CNIC & Password.
- · Details of salary income-pay slip and employer tax deduction
- Details of Other source of income, if any bank profit, rental income, prize bond, dividend etc.,
- Bank statement of all bank accounts from July 01, 2024 till
- Details of personal expenses household, utilities, educational, medical, travelling etc.,
- Details of taxes withheld by FBR if any, i.e.: air tickets, cell
- Details of all assets in your name and in name of dependents:
- Residential, commercial or agriculture property,
- Details of investment shares, bonds, TDRS, Details of Vehicles - Bike and car,
- Details of business capital if any,
- Household and personal items i.e. furniture, electrical appliances etc.,
